

Terms & Conditions:

- 1) "Selamat Hari Raya" contest is organized by Ace Canning Corporation Sdn. Bhd. ("the Organizer") and is exclusively for AEON outlets in West Malaysia.
- 2) The contest is open to all Malaysian aged 18 and above with valid National Registered Identity Card (NRIC). Employees of the Organizer, its related companies, promotion partners, agencies and their immediate family members are not eligible to participate in this contest.
- 3) The contest starts from 01 May 2021 until 30 June 2021 ('Contest Period').
- 4) All entries have to be received latest by 23:59:59 (Malaysia time), 7 July 2021 ('Closing Entries Date'). Any entries received after this period (due to any reason howsoever and/or whatsoever arising) shall be automatically disqualified.
