

## Terms & Conditions:

- 1) This contest is organized by Ace Canning Corporation Sdn. Bhd. (“the Organizer”) and is exclusively for myNEWS outlets in West Malaysia.
- 2) This contest is open to all Malaysian and Permanent residence of Malaysia aged 18 and above with valid National Registered Identity Card (NRIC). Permanent Residence or VISA, Employees of the Organizer, its related companies, promotion partners, agencies and their immediate family members are not eligible to participate in this contest.
- 3) The contest starts from 1<sup>st</sup> August 2022 until 31<sup>st</sup> August 2022 (‘Contest Period’).
- 4) All entries have to be received latest by 23:59:59 (Malaysia time), 31<sup>st</sup> August 2022 (‘Closing Entries Date’). Any entries received after this period (due to any reason howsoever and/or whatsoever arising) shall be automatically disqualified.
