

Terms & Conditions:

- 1) This contest is organized by Ace Canning Corporation Sdn. Bhd. (“the Organizer”) and is exclusively for Village Grocer, B.I.G outlets and The Food Merchant in West Malaysia.
- 2) This contest is open to all Malaysian and Permanent residence of Malaysia aged 18 and above with valid National Registered Identity Card (NRIC). Permanent Residence or VISA, Employees of the Organizer, its related companies, promotion partners, agencies and their immediate family members are not eligible to participate in this contest.
- 3) The contest starts from 10 November 2022 until 31 December 2022 (‘Contest Period’).
- 4) All entries have to be received latest by 23:59:59 (Malaysia time), 31 December 2022 (‘Closing Entries Date’).

Any entries received after this period (due to any reason howsoever and/or whatsoever arising) shall be automatically disqualified.
