

Terms & Conditions

1. This contest is organized by Ace Canning Corporation Sdn. Bhd. (“the Organizer”) and is only for Family Mart in West Malaysia.
2. This contest is open to all Malaysian and residence of Malaysia aged 18 and above with valid National Registered Identity Card (NRIC).
