

Terms & Conditions

1. This contest is organized by Ace Canning Corporation Sdn. Bhd. (“the Organizer”) and is only for Family Mart in West Malaysia.
2. This contest is open to all Malaysian and residence of Malaysia aged 18 and above with valid National Registered Identity Card (NRIC). Permanent Residence or VISA, Employees of the Organizer, its related companies, promotion partner, agencies and their immediate familymembers are not eligible to participate in this contest.
3. The contest starts from 16th August 2023 until 3rd October 2023.
4. All entries have to be received latest by 23:59:59 (Malaysia time), 3rd October 2023. Any entries received after thisperiod (due to any reason howsoever and/or whatsoever arising) shall be automatically disqualified.
