

## **HOMESoy Contest**

### **Terms & Conditions**

#### **Organiser, Duration & Eligibility**

1. The **HOMESoy 'GLAMPINIG' Contest ("Contest")** is organized by Ace Canning Corporation Sdn Bhd (11631-M) ("**Organiser**"). This contest will begin on 15 August 2023 to 30 September 2023 ("**Contest Period**").

2. The Contest is open to all citizens and permanent residents of Malaysia ("**Participant / Participants**") who are eighteen (18) years of age and above with a valid MyKad, except the employees (of the organiser), advertising agents, public relations agents and promotional agencies, including their immediate family members.

3. The Organiser reserves the right to change the terms or duration of the Contest at any time. All contest entries must be sent to the Organiser on or before 30 September 2023.

4. Dear Consumers,

Pengguna yang dihormati,

Di bawah PDPA, terdapat beberapa syarat yang mengawal pemprosesan data peribadi anda sebagai individu ("Individu").
