

“Cuti-Cuti Malaysia” Contest

Terms & Conditions

1. This “Cuti-Cuti Malaysia” Contest (“Contest”) is organized by **Ace Canning Corporation Sdn. Bhd.** [Company No.: 197201000084 (11631-M)] (“ACE”) and **AEON Co. (M) Bhd.** (Company No.: 198401014370 (126926-H)) (“AEON”) (collectively referred to as “the Organizer”)
2. This Contest is open to all legal citizens and permanent residents of Malaysia aged 18 years old and above at the start of the Campaign Period (“Contestant/Contestants”). Employees and family members of the employees of the Organizer are not eligible to participate in this contest.
3. The Contest shall commence from 1 October 2023 to 30 November 2023 (“Contest Period”). The Organizer shall reserve the right to revise the Contest Period at any time without prior notice or assign any reason whatsoever.
4. Any entries received outside of the Contest Period (due to any reason howsoever and/or whatsoever arising) shall be automatically null and void without further notice.
5. To participate in the Contest, Contestants are required to follow the steps below: -
Step 1: Contestants are required to purchase minimum one (1) cup of Drinho /HOMESoy/Dilmah Tea (“Products”) in a single receipt at selected AEON Coco Café at selected AEON stores in Malaysia during the Contest Period.

Step 3: Contestants shall scan the QR Code located at AEON Coco Café cashier counter and Delica cashier counter or key in the link <https://form.jotform.com/232041766498463> for access to the application form(“Form”)
Step 4: Contestants shall insert the required and accurate information and attach the said photo in the Form and submit the said Form attached with the said softcopy of the photo online.
6. Each Contestant shall be required to retain either the hardcopy or the softcopy of receipt(s) of the said purchase for validation purpose by the Organizer, in which failure to do so will result in their submission being null and void.
7. Each Contestant shall be entitled to submit multiple entries but each entry must be accompanied with one (1) original valid receipt throughout the Contest Period. Notwithstanding anything to the contrary, each Contestant shall only be entitled to claim one (1) Prize.
8. Each submission shall be subject to the verification of the Organizer.
