

## Terms & Conditions:

- 1) This contest is organized by Ace Canning Corporation Sdn. Bhd. (“the Organizer”).
- 2) This contest is open to all Malaysian and Permanent residence of Malaysia aged 18 and above with valid National Registered Identity Card (NRIC). Permanent Residence or VISA holders, Employees of the Organizer, its related companies, promotion partners, agencies and their immediate family members are not eligible to participate in this contest.
