

## Terms & Conditions:

- 1) This contest is organized by Ace Canning Corporation Sdn. Bhd. (“the Organizer”) and is exclusively for DonDonDonki in Malaysia.
- 2) This contest is open to all Malaysian and Permanent residence of Malaysia aged 18 and above with valid National Registered Identity Card (NRIC). Permanent Residence or VISA, Employees of the Organizer, its related companies, promotion partners, agencies and their immediate family members are not eligible to participate in this contest.
- 3) The contest starts from 24<sup>th</sup> August – 30<sup>th</sup> September 2024 (‘Contest Period’).
